## 1.0 INTRODUCTION

Binak oilfield in Bushehr province is a part of the southern oilfields of Iran, is located 20 km northwest of Genaveh city.



With the aim of increasing production of oil from Binak oilfield, an EPC/EPD Project has been defined by NIOC/NISOC and awarded to Petro Iran Development Company (PEDCO). Also PEDCO (as General Contractor) has assigned the EPC-packages of the Project to "Hirgan Energy - Design and Inspection" JV.

As a part of the Project, construction of well location, access road, wellhead facilities for W018S shall be done. In addition, construction of new flowline from aforementioned well location to Binak B/C unit are in the Project scope of work.

### GENERAL DEFINITION

## 2.0 GENERAL

- 2.1** This document presents the item material requisitions for Contractor's use as appropriate.
- 2.2** This material requisition covers the requirements for the design, manufacturing, testing and supply of High Density PolyEthylene (HDPE) Geomembrae material (For Waste Pit & Water Pool) as listed below. ## 3.0 REFERENCE / ATTACHED DOCUMENTS



- 3.1** All codes and standards which have been referenced in above mentioned shall be considered.
- 3.2** Specified documents in attachment 1 shall be considered as a part of this material Requisition.
- 3.3** In case of any conflict between the contents of this document or any discrepancy between this document and other project documents or reference standards, this issue must be reported to the CLIENT. The final decision in this situation will be made by CLIENT.
- 3.4** Deviations

Any exceptions/clarifications to codes/standards and specifications must be clearly stated in a separate dedicated section of the proposal in the format submitted in attachment 3.

The proposed deviations/comments list shall include as minimum:

- Reference for the involved specification, chapter and paragraph.
- Technical justification for the non-compliance.
- Detailed description of the proposed alternative.

If no exceptions or clarifications exist, either for the complete referenced document or an individual paragraph, the supplier shall be considered to be in full compliance with the relevant document.

#### 4.0 SUBJECT OF THE SUPPLY

- 4.1** The supplier shall supply all items listed in “TABLE - 1”. The scope of supply is detailed at para. 5. The supplier shall include in the supply, all other equipment/devices/items not listed in the following, but necessary for a good design and a safe operation, taking into account process data and installation conditions such as area classification and climatic conditions.
- 4.2** The grade of shop assembly of the equipment/devices/items supplied shall be at maximum extent to facilitate site erection and pre-commissioning activities.

#### 5.0 LIMITS OF SUPPLY



##### 5.1 SCOPE OF SUPPLY

###### 5.1.1 MAIN DESCRIPTION

The scope of supply includes items listed in “TABLE - 1”.

The supplier shall assume overall responsibility for the design, manufacture, assembly, test and performance of all equipment/devices/items supplied as indicated in this requisition. This shall include, but not be limited to:

- Resolve engineering issues relating to equipment/devices/items within the scope of supply.
- Provide detailed design and documentation of all equipment/devices/items and components within the scope of supply in accordance with attachment 2 of this document.
- Provide all necessary information documents in order to allow the contractor to erect install and verify the proposed equipment/devices/items.
- Implement a quality assurance plan
- The quality plan applied to the scope of supply shall include:
  - QA/QC organization chart and procedures that shall be submitted for approval.
  - Plan for HOLD points in the production process proposed to PURCHASER for witness or approval particular activities.
  - Production schedule indicating main quality manufacturing processes, inspection and tests.
  - Qualification of all personnel performing tests to be reviewed by the inspector
  - Supplier shall also provide the description of the following quality activities:

**6.1** Material shall have good appearance qualities. It shall be free from such defects that would affect the specified properties of the geomembrane.

**6.2** General manufacturing procedures shall be performed in accordance with the manufacturer's quality control guide and/or documents.

## 7.0 INSPECTION AND TESTS

The material shall be inspected and tested in accordance with the quality control plan issued by the supplier and approved by the PURCHASER before the award of the order. The supplier shall in any case conduct all the tests required by contractual documents, specifications, codes and standards, manufacturer standard quality system and keep the relevant documentation.

## 8.0 PACKAGING AND MARKETING

The geomembrane shall be rolled onto a substantial core or core segments and held firm by dedicated straps/slings, or other suitable means. The rolls must be adequate for safe transportation to the point of delivery, unless otherwise specified in the contract or order.

## 9.0 UNIT RESPONSIBILITY



- 9.1** VENDOR shall be responsible for the design, engineering, co-ordination, supply, delivery, testing, final check-out and satisfactory operation of the equipment/devices/items. The engineering coordination also includes responsibility for handing and expediting drawings.
- 9.2** Also VENDOR shall be responsible for ensuring that all relevant information and documentation is passed on the sub-suppliers.

## 10.0 GUARANTEE AND WARRANTY

- 10.1** All material and Equipment/Devices/Items in VENDOR's scope of work/supply shall be guaranteed by VENDOR.
- 10.2** The guarantee period shall be 120 months from the date of delivery or 114 months from the installation date of each equipment/packages at site.
- 10.3** VENDOR shall guarantee the performance of supplied items (if any).
- 10.4** VENDOR shall guarantee that the Equipment/Device/Item is suitable for the operating conditions herein specified, and that all materials and components are free from any defects; verifications of all calculations are in VENDOR's responsibility.
- 10.5** VENDOR shall unconditionally guarantee the materials and workmanship of all material and/or services. If, within the guarantee period, any defects occur which are due to faulty material and/or services included in his scope (design, manufacturing, inspection, testing, supply & etc.), VENDOR shall, at his own expense, repair or adjust the condition, or replace the material and/or services to the complete satisfaction of CLIENT's representative. These repairs, replacement or adjustments shall be made only at such time as will be least detrimental to the operation of the CLIENT's business.
- 10.6** VENDOR warrants promptly repairing or replacing the defective parts in the warranty period.
- 10.7** Vendor shall ensure a correct and safe operation of the unit, providing all safety protection Devices.
- 10.8** Vendor shall be responsible for the safe, reliable, continuous functioning of the
