

1.0 INTRODUCTION

Binak oilfield in Bushehr province is a part of the southern oilfields of Iran, is located 20 km northwest of Genaveh city.

With the aim of increasing production of oil from Binak oilfield, an EPC/EPD Project has been defined by NIOC/NISOC and awarded to Petro Iran Development Company (PEDCO). Also PEDCO (as General Contractor) has assigned the EPC-packages of the Project to "Hirgan Energy - Design and Inspection" JV.

As a part of the Project, a New Gas Compressor Station (adjacent to existing Binak GCS) shall be constructed to gather of 15 MMSCFD (approx.) associated gases and compress & transfer them to Siahmakan GIS.

4.0 SUBJECT OF THE SUPPLY



The supplier shall supply On/Off & Shutdown Valves. The scope of supply is detailed at part 5. The supplier shall include in the supply, all other equipment/devices/items not listed in part 2 5, but necessary for a good design and a safe operation, taking into account process data and installation conditions such as area classification and climatic conditions.
