1.0 INTRODUCTION

Binak oilfield in Bushehr province is a part of the southern oilfields of Iran, is located 20 km northwest of Genaveh city.

With the aim of increasing production of oil from Binak oilfield, an EPC/EPD Project has been defined by NIOC/NISOC and awarded to Petro Iran Development Company (PEDCO). Also PEDCO (as General Contractor) has assigned the EPC-packages of the Project to "Hirgan Energy - Design and Inspection" JV.

GENERAL DEFINITION

THIRD PARTY INSPECTOR (TPI):	The firm appointed by EPD/EPC CONTRACTOR(GC) and approved by COMPANY (in writing) for the inspection of goods.
SHALL:	Is used where a provision is mandatory.
SHOULD:	Is used where a provision is advisory only.
WILL:	Is normally used in connection with the action by COMPANY rather than by an EPC/EPD CONTRACTOR, supplier or VENDOR.
MAY:	Is used where a provision is completely discretionary.

The installation site is in south of Iran with corrosive, hot and medium humid atmosphere. Therefore, all equipment shall be designed to fully comply with the performance specification in the environmental conditions. For more information refer to “Process Basis Design; section 11”.

For the Ambient Conditions, Special Care should be paid to:

- Enclosures of Equipment for Outdoor Installation
- Painting and Coating of Metal Parts to Resist to the Severe Environmental Conditions

Any environmental derating factors shall be considered by vendor before design.

3.5 Guidance for Use of This Document

The amendments/supplement to the related IPS Standard(s) given in this document are directly related to the equivalent sections or clauses in the IPS Standard(s). For clarity, the section and paragraph numbering of the IPS Standard(s) has been used as long as possible. Sub. (Substitution): The IPS Std. clause is deleted and replaced by a new clause.

Del. (Deletion): The IPS Std. clause is deleted without any replacement.

6.0 APPLICATION

6.3 Where the calculated system power factor at the LV & MV side is less than 90% lagging, capacitor bank/s shall be installed. The capacitor bank/s shall be sized to improve the system power factor to 95% lagging at system full load. (Mod)

7.0 CONSTRUCTION REQUIREMENT

7.1.3 Unless otherwise specified in data sheet, the degree of protection of indoor enclosure shall be IP 42 and that of outdoor enclosure shall be IP 54 according to IEC 60529 without using the floor as part of the enclosure. Outdoor enclosure shall be provided with sloping sunshade. (Mod)

7.1.9 The assembly shall be free standing having access from front, indoor type and provided with a power entrance compartment. The incoming cable shall enter the power compartment from below. (Add)
